Deadline for April 2024 LSAT Exam

The registration deadline for the April 2024 LSAT is **Thursday, February 29 at 11:59 p.m. ET**. Most test takers will have the option to test in an online, live remotely proctored environment or in person at a test center. Although test takers will be asked their preference during registration, they will have until scheduling opens to make a decision.

The primary test dates for the April 2024 LSAT are Thursday, April 11; Friday, April 12; and Saturday, April 13. In most cases, test takers will have the option to choose the day and time of their test.

Updates for LSAT Prep Materials and the LSAT Exam

For students planning to take the August 2024 LSAT and beyond as well as those planning to use LawHub/Khan Academy to study for the LSAT, here are some updates you should know about!

- LawHub now provides two sets of practice tests: one for the old LSAT format and one for the new one (two LR sections + one RC section)
- Khan Academy's test prep videos, explanatory articles, and sample problem sets will be added to LawHub and available for free by mid-March
- LSAC will be announcing the test dates for all eight LSAT administrations in the 2024-2025 testing year later this month
